Location:	Stars & Strikes Parking Area 2400 Acworth/Hiram Parkway Dallas, GA 30157 Corner of Highways 120 and 92
Event Hours:	8:00 A.M. until 4:00 P.M.
Set-Up:	6:30 A.M. until 8:00 A.M. No set up will be permitted after 8:00 A.M.
Packing-Up:	All vendors are to be packed up and off the premises by 4:30 P.M., but not before 3:00 P.M. Vendors are responsible for cleaning up their own area.
Parking:	Designated areas only.
Cancellations:	There are no refunds whatsoever regardless of the situation, whether sick, no shows, or cancellations, inclement weather, acts of God, or any other reason.
Type of Merchandise/Banned Items:	<p>The following items are not allowed to be sold or brought to the Community Yard Sale:</p> <ul style="list-style-type: none"> <li>• Firearms or ammunition; fireworks; popping caps; dynamite or other similar explosive material; dangerous or poisonous chemicals or other similar items considered hazardous to the public are not allowed.</li> <li>• Animals are not allowed.</li> <li>• No offensive books or other material (pornography, occult, or witchcraft).</li> <li>• No illegal, counterfeit or stolen items.</li> <li>• No drug-related paraphernalia.</li> </ul> <p>The Dallas Lodge #182 F&amp;AM Committee reserves the right to limit or restrict the sale or display of any merchandise they consider inappropriate in running an orderly and family-oriented event.</p>
Vendor Space:	Spaces are 18x18 (two parking spots). All vendors must keep their merchandise within the white lines of their spaces. Merchandise or display racks are not allowed in the aisles. Vendors are allowed to bring tables and chairs. Any merchandise left will be disposed of or given to charity. Public address systems and music are not permitted to be used within the vendor's spaces. A central public address system and music are to be provided by the event coordinators.

Selling of Food and Beverages:	No alcoholic beverages may be brought into the event. Any food items for sale must be cleared through a Committee member prior to the event.
Selling Merchandise:	Dallas Lodge #182 F&AM will not mediate any price or authenticity problems between customers and vendors. If there is a problem, the police shall be called.
Vendor Garbage and Cleanup:	Vendors are required to clean up their rented spaces at the close of the yard sale.
Booth Signage:	One sign, not to exceed 6 square feet is allowed per vendor to denote the name of the vendor and the merchandise sold.
Vendor Dress and Behavior:	Vendors or their agents are expected to dress and conduct themselves in a proper and professional manner at all times. All vendors must wear full clothing and shoes. Profanity, loud boisterous action or physical violence will not be permitted. Vendors caught stealing or destroying other vendors' merchandise or displays will be barred from the event and subject to full penalties under the law. Offending vendors will be required to leave the event.

These are the basic rules of this event. Other rules and regulations deemed in the best interest of the event will be added, amended, or changed and all vendors are required to adhere to these policies. By renting in this event, every vendor hereby agrees to adhere to these rules.
